Nonetheless, this edition retains the major cases and discussions of established legal doctrine. One new feature of the Sixth Edition is an annotated Web Directory which will facilitate information gathering and ease any inconvenience related to the decision to trim down some of the material in the book. For example, the NBA Standard Player Contract is readily available from the NBA Player's Association website. Collective bargaining agreements and NCAA regulations are also generally accessible off internet sites.
