Those who teach with Fisher's Evidence (3d ed. 2013) will benefit from paginated cross-references between the casebook and this rulebook.

A case supplement analyzes the Supreme Court's recent grant of certiorari in *Warger v. Shauers*, which will be argued in October 2014, as well as the Court's ruling in *Salinas v. Texas*, 133 S. Ct. 2174 (2013). *Warger v. Shauers* raises questions in the application of rule 606(b). *Salinas v. Texas* addresses the prosecution's use in its case-in-chief of a suspect's silence in response to noncustodial police questioning.
